#### CASE ASSIGNMENT

On February 21st, 2013 Sgt. Dove asked me to contact **Redacted Redacted** regarding sexual abuse. Sgt. Dove advised me that he investigated a separate sexual abuse case that involved **Redacted Redacted** and **Redacted** David Hamblin. Sgt. Dove advised me that the case was sent to David Sturgill at the Utah County Attorney's Office.

#### CONTACT WITH REDACTED REDACTED

I called **Redacted Redacted** and she stated that she and **Redacted** needed to report that they were sexually abused. **Redacted** stated that they could meet at the Provo Police Department on February 22nd, 2013 for interviews. **Redacted** stated that **Redacted** is out of the state but she could provide a written statement at a later time.

#### INTERVIEWS WITH REDACTED REDACTED, REDACTED AND REDACTED HAMBLIN

On February 22nd, 2013 Detective Webb, victim advocate Traci Anderson, and I met with **Redacted Redacted**, **Redacted**, and **Redacted Redacted** at the Provo Police Department. **Redacted**, **Redacted**, and **Redacted** stated that there was a long history of sexual abuse. They stated that they would disclose a few incidents and they

would provide more detailed written statements at a later time. Detective Webb and I interviewed **Redacted**, **Redacted**, and **Redacted** separately in the soft interview room. The interviews were audio and video recorded.

## **INTERVIEW WITH REDACTED (REDACTED) REDACTED**

**Redacted Redacted** disclosed the following information:

**Redacted** watched her **Redacted** being raped by **Redacted** David Hamblin in Provo, Utah. One time **Redacted**, **Redacted**, and **Redacted** were sleeping in **Redacted** Spring City house. **Redacted** was in her toddler bed. David came in and took off his pants. David took the covers off of **Redacted** and he raped her.

When **Redacted** was approximately three years old David, **Redacted** Roselle, **Redacted**, **Redacted** **Redacted**, David's friends and **Redacted** hiked a hill in Spring City. They went to an area that had pine trees, a fire pit and logs to sit on. **Redacted** sat on **Redacted** 's lap. David went around with a zip lock bag full of dried peyote and he gave it to people with a spoon. David tried to give peyote to **Redacted** and **Redacted** objected. **Redacted** offered to take **Redacted**'s portion. David shoved the spoon in **Redacted**'s mouth. **Redacted** has spoken to Roselle about that experience and Roselle claimed that she was the one holding **Redacted**. Roselle claimed that she was the one that objected to **Redacted** taking the peyote.

When **Redacted** was approximately **Redacted** or **Redacted** years old they lived at a house in Provo, Utah. **Redacted** was in the upstairs bathroom with David. David urinated in the toilet and then he told her to open her mouth. David put his penis into **Redacted**'s mouth and told her to suck. **Redacted** sucked David's penis and then he ejaculated into the toilet. When **Redacted** was a teenager she told **Redacted** about that incident.

When **Redacted** was approximately **Redacted** years old they lived at a condo near Timp View High School in Provo, Utah. **Redacted** would take showers with Roselle. The shower had a removable shower head. Roselle would use the shower head to masturbate **Redacted**. Roselle had **Redacted** hold the shower head to masturbate herself and Roselle.

When **Redacted** was approximately **Redacted** years old they lived at the same condo in Provo, Utah. Roselle would have **Redacted** massage Roselle's vagina with a vibrator. Roselle would have **Redacted** nurse on Roselle's breasts. Roselle would put her fingers in **Redacted**'s buttohole and vagina.

When **Redacted** was approximately **Redacted** years old they lived at the same condo in Provo, Utah. Roselle got out of the bath and sat on the stairs. Roselle told **Redacted** to nurse. The term they used to nurse was "nursy nursy". **Redacted** sucked on one of Roselle's breasts. Roselle pushed **Redacted**'s head towards Roselle's vagina and told her to lick it. **Redacted** licked Roselle's vagina until Roselle had an

orgasm.

**Redacted** began lactating her senior year of High School. **Redacted** went to a doctor and had tests done. The test results indicated that she had a high rate of prolactin. The doctor told **Redacted** that she needed to stop touching herself. The test results scared Roselle and Roselle stopped touching **Redacted's** breasts.

Approximately two months ago **Redacted** was at her current home in Provo, Utah and Roselle came into her bedroom during the middle of the night. Roselle lifted **Redacted's** blankets and pulled **Redacted's** pants down. Roselle penetrated **Redacted's** vagina with either her tongue or her fingers. The sexual abuse has decreased since Roselle married Ford.

Two nights ago **Redacted** told **Redacted** and **Redacted** about the abuse then they talked to **Redacted** on Skype about it. **Redacted** stated that there were many more sexual abuse incidents but she did not want to talk about them.

#### **INTERVIEW WITH REDACTED (REDACTED) REDACTED**

**Redacted Redacted** disclosed the following information:

**Redacted** was sexually abused by both of **Redacted** almost daily for as long as she can remember. **Redacted** would participate in **Redacted** orgies with **Redacted** and **Redacted**. **Redacted** has witnessed Roselle performing oral sex on **Redacted**, **Redacted** and **Redacted**. **Redacted** has witnessed **Redacted**, **Redacted** and **Redacted** performing oral sex on Roselle and David. The sexual abuse occurred almost daily for thirteen years starting when **Redacted** was an infant. **Redacted** didn't disclose the abuse that involved Roselle because **Redacted** was still **Redacted** and Roselle would have notified David.

**Redacted** told **Redacted** that she was sexually abused. Yesterday **Redacted** received a phone call from **Redacted** and **Redacted** stated that **Redacted** wants to leave home. **Redacted** and **Redacted** went to **Redacted's** house and they talked to **Redacted** on Skype. **Redacted** has already disclosed some of her sexual abuse history to Sgt. Dove and Dave Sturgill.

When **Redacted** was approximately **Redacted** or **Redacted** years old they lived at a house near 2200 North 280 East in Provo, Utah. Roselle was wearing a robe and David was wearing a shirt but no pants. Roselle closed the curtains in the living room and she put a blanket on the ground. David and Roselle sat on the blanket. **Redacted** and her **Redacted** were naked. Roselle started this gross game that they often played where they would pretend to be kittens. David and Roselle told the children to lick each other.

David started masturbating. Roselle called **Redacted** over to her and David told the other girls to lick his penis. **Redacted** and **Redacted** licked David's penis. David told **Redacted** to suck on him and he put his finger into **Redacted's** vagina. David started ejaculating. **Redacted** took her mouth off of his penis and he pushed **Redacted's** head back

on. Roselle told **Redacted** and **Redacted** to suck on her nipples and they did.

David and Roselle would also have the children pretend to be babies. One time Roselle took them into the bedroom. **Redacted** was on the bed naked. Roselle was naked under her robe and David was naked. Roselle told them to act like babies. Roselle started saying "nursy nursy" which is a term they used to nurse. Roselle told **Redacted** and **Redacted** to nurse on Roselle. David said he had a big bottle of milk for **Redacted**. David grabbed his penis and moved it around. David told **Redacted** to suck on it and she did. Roselle told **Redacted** to lick Roselle's vagina.

Roselle told **Redacted** to put her finger in Roselle's vagina while **Redacted** licked her vagina. **Redacted** and **Redacted** both did what Roselle told them to do. David turned around and went into what he called the stink bug position. David told **Redacted** to lick his anus and she did.

When **Redacted** was approximately **Redacted** or **Redacted** years old they lived at a house in Spring City. Roselle told **Redacted** to take a nap with her. Roselle started humping **Redacted** and she rubbed her vagina against **Redacted**. Roselle put her finger in **Redacted**'s vagina. Roselle grabbed **Redacted**'s head and pushed **Redacted**'s face onto Roselle's vagina. Roselle told **Redacted** to lick her vagina. **Redacted** tried to push away but Roselle kept forcing her head down.

When **Redacted** was **Redacted** years old she was at **Redacted**'s condo in Provo, Utah. **Redacted** planned on going to seven peaks with her friends. She had just started her period but she didn't know how to use a tampon. She put in the applicator and she felt it falling out. She went to get in her friend's car. She dropped her bag and she picked it up. She later went to the bathroom and had no tampon.

She told **Redacted** and **Redacted**. Roselle came in and asked what was happening. Roselle said it was probably stuck and she could get sick if she didn't get it out. Roselle told **Redacted** that she didn't want her to get sick. Roselle had **Redacted** sit on the bed and spread her legs.

Roselle got on her knees and put her fingers in **Redacted**'s vagina. Her nails scraped and it hurt. Roselle started sucking on **Redacted**'s vagina and she put her tongue inside **Redacted**'s vagina. **Redacted** tried to close her legs and Roselle hit her. Roselle told **Redacted** to do it to her. Roselle took off her robe and sat on the bed. Roselle told **Redacted** to get on the ground. Roselle pushed **Redacted**'s head towards Roselle's vagina and she told **Redacted** to lick her vagina. **Redacted** licked Roselle's vagina.

When **Redacted** was approximately **Redacted** years old they lived at a condo in Provo, Utah. **Redacted** came home from school and she heard moaning noises in **Redacted**'s room. Roselle was performing oral sex on **Redacted**. Roselle yelled at **Redacted** and told her to get out. **Redacted** walked over to the bed and pulled **Redacted** away. Roselle started hitting **Redacted**. Roselle threw an object at **Redacted**'s head and that is all **Redacted** could

remember.

When **Redacted** was approximately **Redacted** years old Roselle told **Redacted** and **Redacted** to suck on Roselle's breasts. **Redacted** and **Redacted** sucked on Roselle's breasts. Roselle pushed **Redacted**'s head towards Roselle's vagina. Roselle told **Redacted** to lick her vagina and she did. Roselle threatened to commit suicide if they ever told anybody.

When **Redacted** was approximately **Redacted** years old she was at a condo in Provo, Utah. **Redacted** was on pain medications because of an injury and she had fallen asleep. When **Redacted** woke up Roselle was sitting on her face and Roselle was rubbing her vagina against **Redacted**'s face.

## INTERVIEW WITH REDACTED

**Redacted** disclosed the following information:

**Redacted** has performed oral sex on Roselle and Roselle has performed oral sex on her. **Redacted** has witnessed Roselle performing oral sex on **Redacted**, **Redacted** and **Redacted**. **Redacted** has witnessed **Redacted**, **Redacted** and **Redacted** performing oral sex on Roselle and David. **Redacted** has performed oral sex on David and he has performed oral sex on her. David has also raped her vaginally and anally. Roselle and David would have the children pretend to be cats or babies and they would nurse on Roselle when they would say "nursy nursy".

David would rape the children or physically abuse them as punishment. If they vomited when they were performing oral sex then David would make them eat the vomit off the ground or he would put it on a rag and put it on their face to suffocate them with it.

When **Redacted** was approximately **Redacted** or **Redacted** years old they lived at a house in Provo, Utah. Roselle told **Redacted** that it was time to take a nap. Roselle told **Redacted** to get undressed and she did. Roselle got undressed also. They got into bed together. Roselle had **Redacted** nurse on her breasts. Roselle straddled **Redacted** and Roselle rubbed her vagina against **Redacted**'s vagina. Roselle got on her back and told **Redacted** to lick her vagina. **Redacted** licked Roselle's vagina.

When **Redacted** was approximately **Redacted** years old they lived at a house in Provo, Utah. David was on the couch and Roselle was lying on the floor. David had **Redacted** and **Redacted** sit by him on the couch. David had **Redacted** masturbate him with her hand while **Redacted** licked the top of his penis. Roselle had **Redacted** perform oral sex on **Redacted**.

## MEETING BETWEEN REDACTED AND ROSELLE STEVENSON

**Redacted** stated that she would speak to Roselle about the abuse and record the conversation. Detective Webb, Traci Anderson, **Redacted**, **Redacted**, **Redacted** and I



met with Investigator Scott Finch and Investigator Greg Knapp at the Utah County Attorney's Office. Scott Finch and Greg Knapp placed recording equipment on **Redacted**. **Redacted** went to Roselle's residence in Provo, Utah. Scott Finch, Greg Knapp, Traci Anderson and I parked outside the residence and monitored the meeting between Roselle and **Redacted**.

**Redacted** told Roselle that she took **Redacted** to lunch on Wednesday and **Redacted** doesn't want to come home. **Redacted** told Roselle that the **Redacted** talked about Roselle doing sexual things to them. Roselle stated that she didn't know what **Redacted** was talking about. Roselle stated that she has no memories of that. **Redacted** asked Roselle how they all remember the same things. Roselle stated that her only explanation is that David was trained in hypnosis. Roselle stated that **Redacted** has said that Roselle was involved in the abuse and Roselle spoke to her therapist about it. Roselle stated that she tried to get **Redacted** therapy after she disclosed that she was raped by David.

#### MEETING BETWEEN ROSELLE, FORD, REDACTED, REDACTED AND REDACTED

**Redacted**, **Redacted** and **Redacted** stated that they wanted to speak to Roselle about the abuse and record the conversation. Traci Anderson, Detective Webb and I went to **Redacted**'s residence and we put audio recording devices in the living room. Traci, Detective Webb and I sat in a bedroom with the door shut and we listened to the conversation between Roselle, Roselle's husband Ford, **Redacted**, **Redacted** and **Redacted**.

Roselle stated that she was very surprised that **Redacted** accused her of sexual abuse. Roselle stated that she doesn't know why **Redacted** would say that and she doesn't have any recollection of anything like that. Roselle stated that she is not trying to hide anything and she didn't do that.

Roselle stated that this is the first that she has heard of anything like that. **Redacted**, **Redacted** and **Redacted** told Roselle the sexual things that she did to them. Roselle stated that she didn't know what they were talking about and she didn't do that to them. Roselle stated that she has no memory of doing it.

Roselle stated that when **Redacted** came back from **Redacted** **Redacted** wanted to talk. Roselle stated that **Redacted** said she had memories of David that she wanted to report to the police and **Redacted** inferred that Roselle had been involved in some of the abuse. Roselle stated that **Redacted** said she talked to Kathy Hudley. Kathy has a son that was abused and Kathy said sometimes people can be programed to do things they don't want to do. Roselle stated that she spoke to Kathy. Kathy had two names of therapists for Roselle because Roselle said all of **Redacted** had memories.

Roselle stated that she spoke to **Redacted** on the phone to clarify where they stood because **Redacted** was being distant and **Redacted** replied that she thought Roselle was

involved in the abuse. Roselle stated that she asked **Redacted** what she meant but **Redacted** didn't reply. The phone conversation was about one week after David's arrest.

Roselle stated that after **Redacted** made the accusation then she went and spoke to her therapist about it. Roselle stated that she also went to her bishop and the temple to pray about it. Roselle stated that she did not sexually abuse any of them and it seems like it was made up. Roselle stated that David use to talk about programing. Roselle stated that she didn't know if she had been programed. **Redacted** told Roselle about the memory she had when David put peyote in her mouth. Roselle stated that she was holding **Redacted** and she told David no but he still put the peyote in **Redacted**'s mouth.

**Redacted** asked Roselle if she would be willing to give them her therapy records and Roselle said she would think about it. Roselle stated that there is a possibility that she was programed if she has done any of these horrible things.

## EVIDENCE

On February 25th, 2013 Scott Finch gave me the recordings of the meeting between **Redacted** and Roselle.

## THERAPY RECORDS AND RECORDINGS

**Redacted** advised me that Roselle gave them her therapy records. **Redacted** gave me Roselle's therapy records and a disk that contained recordings. The recordings include conversations that they had with Roselle and Roselle's therapist. Roselle's therapist stated that there is nothing in the records indicating that Roselle participated in the abuse. Roselle stated that if they report her to the police it will muddy the water in the case with David.

Roselle's therapy records indicate the following information:

## INTERVIEW WITH BRETT BLUTH

On May 29th, 2013 I received a phone call from Dave Sturgill. Dave asked me to contact Brett Bluth for information regarding this case. I called Brett and he agreed to meet for an interview. On May 31st, 2013 I spoke to Brett Bluth in the soft interview room at the Provo Police Department. The interview was audio and video recorded. Brett disclosed the following information:

A friend told him that David Hamblin was arrested and then he contacted Dave Sturgill. When Brett was approximately 23 years old he told his bishop that he

was homosexual and his bishop told him to go to David Hamblin for therapy. Brett went to David's office near the temple in Provo, Utah. One time he was sitting in David's rocking chair while David stood next to him. David pulled his own pants down and exposed his penis. Another time he was sitting in David's rocking chair while David was standing next to him. David took Brett's hand and put it on David's penis.

Another time he was sitting on the sofa with David. David asked him if he wanted some of his fluid. David unzipped his own pants and exposed his penis. David put his hand on the back on Brett's head and pushed his head towards David's penis. He performed oral sex on David for about 30 seconds and then he stopped. David pushed his head down again and he continued performing oral sex on David. David ejaculated into Brett's mouth and he swallowed the semen. David then performed a priesthood blessing on Brett.

A few months later he received a phone call from David and David gave him a phone number. Brett called the number and a lady asked him if he wanted to participate in a peyote ceremony. He became a regular at the ceremonies and David was there sometimes. He told most of his family and friends what happened with David. At one of the ceremonies David disclosed to the group that he had sexual interactions with Brett. David put Brett's head in David's lap. The other group members put their hands on Brett and they prayed for him to forgive David.

Brett heard that there were two other female victims of David at the peyote ceremony. He didn't know who they were because they never came forward. When Brett was approximately 26 years old he had a breakdown. He and his father Oscar created a plan to confront David. Brett told his bishop Conrad Gottfrenson but he didn't want to get involved.

David's friend Joe Benion told David that he was going to bring him lunch. Brett and Oscar went with Joe and surprised David. David's bishop happened to be there also. Oscar asked David how he could do those sexual things to Brett. David's bishop confirmed that he was aware of the sexual acts. They told David that he needed to report it to Dopple or they would. Brett called Dopple a few days later and they confirmed that David called them and they revoked his license.

On June 13th, 2013 I met with Brett at the Provo Police Department and he gave me a typed statement.

#### INTERVIEW WITH BRANDON BEAGLEY

Sgt. Dove gave me a disk that contained an interview that he conducted with Brandon Beagley. Brandon disclosed that he and his wife went to David for therapy. David didn't want them to report their abuse. David just wanted them to work through it in group. David said it is not about bringing people to justice. David said it is about healing.

Another group member Christa Swenson had a son that was sexually abusing his brother. David worked with the child in front of everybody in group. Brandon reported the incident to DCFS. David would hypnotize them and he would encourage the use of peyote. David stated that his **Redacted** mother told them to lie on the stand so she could get custody of them and she convinced **Redacted** that they were abused.

## DCFS RECORDS

I contacted DCFS and obtained a copy of the report that Brandon made to DCFS. The child abuse neglect report is 1796642. The report lists Brandon Beagley as the referent and Christa Swenson as the mother of the child. Refer to the attached child abuse neglect report for further details.

## EVIDENCE

On December 20th, 2013 I received a phone call from Dave Sturgill. Dave asked me to meet him at his office to collect evidence from **Redacted Redacted**. I went to the Utah County Attorney's Office and met with **Redacted** and Dave. **Redacted** gave me a white plastic bag that contained two dolls, a brown whip, a white dress and a tan canopy.

**Redacted** stated that **Redacted** wore the dress while she was sexually assaulted and the whip was used during sexual assaults. **Redacted** stated that the canopy was used when she was sexually abused by many people. **Redacted** stated that the two dolls were used in ceremonies when they didn't have real babies. I took the items to the Provo Police Department. Detective Bascom and I sealed the evidence. I booked the items into an evidence locker at the Provo Police Department.

## DISPOSITION

I will now forward a copy of this report to Dave Sturgill at the Utah County Attorney's Office for his review.
