#### Narrative

On 6/27/18 at approximately 1534 hours I was dispatched to a delayed hit and run involving a parked vehicle that occurred at 541 E 500 N. The caller was the

owner of the vehicles father because the vehicle owner was out of town on her honeymoon. I responded and found V2 which had moderate front end damage. V2 was parked on the North side of the lot with its nose against the fence which split the property at 566 N 500 E from the property of 541 E 500 N.

I made contact with the father who informed me that the property manager called him regarding his daughters parked unoccupied vehicle being hit. The father stated that the property owner gave him the plate for V1 and the drivers info which was Parley Brown. The father provided me with the plate to V1 at which point I observed V1 parked on the other side of the fence at 566 N 500 E.

I found through the father that a resident witness named David Hamblin saw the accident and retrieved the driver of V1's info which he gave to the property manager who gave it to him. I made contact with David Hamblin in regards to what occurred. David informed me that he heard a loud bang at approximately 0800 hours. David stated he ran out to see what occurred and found Parley Brown had backed through a Provo City Power Box, the fence, and into the bumper of V2. David stated that Parley did not want to involve Police so David retrieved his information to give to the vehicle owner so it could be handled. David informed me that the power went out do to the box being hit so he contacted Provo Power. David stated he understood why Parley didn't want Police involvement and was going to help him get in contact with the owner. David stated he gave the info to the manager so that it could get to the owner.

I made contact with Parley Brown at his address. Parley informed me that he didn't want to call Police because he did not want a ticket. Parley informed me Power already came out and fixed the power box so I didn't get to see the damage which occurred to the box. Parley stated that at 0800 hours he was backing from his stall which was North of the fence. Parley stated that as he was backing he forgot he left his water bottle on the roof of his truck. Parley stated the bottle fell off she while still in reverse he opened his door and reached down to pick it up. Parley stated that the truck began to roll backward at which point he stated he went to stomp on the break but accidentally stomped on the gas. Parley stated the truck lurched backward with the door open. Parley stated his truck hit the power box with his door as the rear went through the fence and into the front of V1.

I observed that Parley's truck had minor damage to the rear bumper and moderate damage to the driver side door. Parley completed a witness statement as to what had occurred.

Provo Power responded out to the scene and provided me with the ticket for the repair made to the box. Provo City Power gave me a quote of the damage caused to the box which came to \$2,672.17. Although Parley did not call Police due to fear he would be ticketed he did attempt to contact the vehicle owners to handle the accident. Parley was not charged with any crime due to the accident being on

private property and his attempt to give info to owners.

The property line fence was damaged but it was very minor. I was unable to locate the ownership to the fence for this report.
